

# ARTICLES OF INCORPORATION FOR BURNHAM BUSINESS MANAGEMENT, INC.



MELAHASSEE, FLORIDA

The undersigned does hereby subscribe to, acknowledge and file the following Articles of incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE I: NAME

The name of the corporation is BURNHAM BUSINESS MANAGEMENT, INC.
