

Please find enclosed my 2005 Annual Report, a \$150.00 check, and a copy of my bank statement. This letter is to request that the late filing fee be waived, due to the fact that I mailed the original report out on April 21, 2005, but it was never received by the Division of Corporations.

If you look at the report you will see that it is a copy of the original that was sent out with an original signature added. The bank statement that is enclosed shows the gap in my checking account, where the first check written to the Florida Department of State was never cashed. When I reconciled my statement I realized that I should follow up with the Department of State to find out if my report was ever received. After speaking with Tina, who was most helpful, she told me the Report had not been received and gave me the advice to write a letter explaining the circumstances and to request that the penalty be waived.
