The undersigned, for the purpose of forming a corporation under the Florida Professional Services Corporation Act, does hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: HIGHLANDS ANESTHESIA ASSOCIATES, P.A.
 - Article 2. **Duration.** The duration of the Corporation is perpetual.
- Article 3. Purpose. The purpose for which the Corporation is organized for the practice of medicine including anesthesiology.
