ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Ficrida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is COMMERCIAL DRIVER LICENSE TESTING CENTER, INC.
