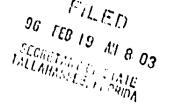

ARTICLES OF INCORPORATION OF



JAMES FREDERICK, INC.

ARTICLE I

NAME: The name of this corporation is

JAMES FREDERICK, INC.

ARTICLE II

DURATION: This corporation shall have perpetual duration.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of transacting any and all lawful business.
