AMENDMENTS

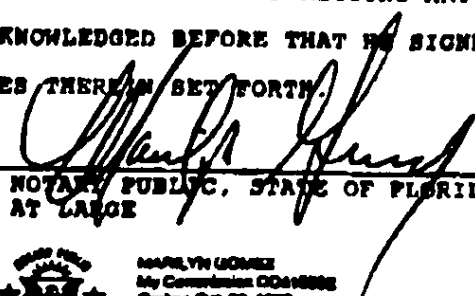
