ARTICLES OF INCORPORATION

or

YE OLDE GOLF SHOPPE OF CENTRAL FLORIDA, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is YE OLDE GOLF SHOPPE OF CENTRAL FLORIDA, INC.

ARTICLE II - EFFECTIVE DATE AND DURATION

The effective date of incorporation of the corporation is the date of filing of these Articles with the Florida Secretary of State. The period of duration of the corporation is perpetual.
