The undersigned hereby forms a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. The name of this corporation is BRANCH REALTY TALLAHASSEE, INC.

2. Nature, Purpose and Powers. This corporation shall have perpetual existence, commencing on the date that these Articles are executed and acknowledged. It will have the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.

3. Capital Stock. This corporation is authorized to issue 100,000 shares of \$.10 par value common stock.

4. Initial Registered Agent and Office. The name and address of the initial registered agent and office of this corporation is: Marlow White at the firm of Lewis & White, L. C., 216 W. College Ave. #201, Tallahassee FL 32301.

5. Initial Board of Directors. This corporation shall have one director initially. 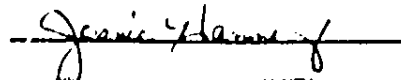
