

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

Article I
Name

The name of the corporation is INFOSERV INTERNATIONAL, INC.

This corporation shall exist perpetually.
