ARTICLES OF INCORPORATION

REMARC ENTERPRISES, INC.

The undersigned incorporator to these Articles of Incorporation, a Florida corporation. hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE 1 - CORPORATE NAME

The name of the Corporation is REMARC ENTERPRISES, INC..

<u>ARTICLE II - NATURE OF BUSINESS AND POWERS</u>

The general nature of the business to be transacted by this Corporation is to engage in the business of consultation and administration of open air animal shelters for equine activities, including but not limited to the maintenance, care, training, feeding of animals, and the design, maintenance, consultation, construction, and development of animal shelters; and the design, maintenance, consultation, construction and development of any other building structures for commercial or residential use; and to engage in any other lawful activities within the purpose for which corporations may be organized under the Florida Business Corporation Act.

The corporation shall exercise any and all powers that corporations have and may exercise under the laws of the State of Florida and as the same may be amended.
