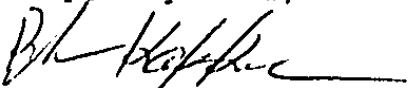

The undersigned, acting as incorporator of Hair Designs by Bluma, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

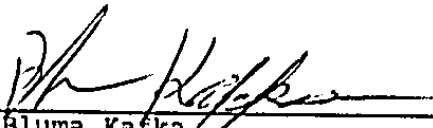
#### **ARTICLE IX - BYLAWS**

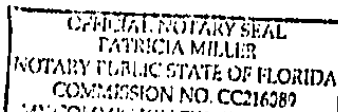
