ARTICLES OF INCORPORATION

OF

ARTISAN COMPUTER SERVICES, INC.

The undersigned Subscriber(s), being natural persons and competent to contract for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I - CORPORATE NAME

The name of this corporation is ARTISAN COMPUTER SERVICES, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 500 shares of common stock, having a par value of \$1.00 per share.

ARTICLE IV - TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon filing of the articles.

ARTICLE V - REGISTERED AGENT AND INITIAL REGISTERED OFFICE
