

# ARTICLES OF INCORPORATION OF BRAZIL TRUST, INC.



## ARTICLE I - NAME

The name of this corporation is Brazil Trust, Inc., a Florida corporation.

## **ARTICLE II - DURATION**

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida General Corporation Act.


