ARTICLES OF INCORPORATION

OF

EWS, Inc.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is EWS, Inc.

ARTICLE TWO

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 805 West James Lee Blvd., Crestview, Florida 32536.

ARTICLE THREE

CORPORATE DURATION

The duration of the corporation is perpetual and the initial date of incorporation shall be the date the articles are filed with the Secretary of State.

ARTICLE FOUR

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 1. To engage in the business of Environmental Waste services.
