ARTICLE I-NAME OF CORPORATION

The name of this corporation is: ALEXUS CORPORATION

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

ARTICLE II-PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business, including but not limited to the following: Representing Manufactured Products.


