ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is COFERO DISTRIBUTION CORP., a Florida Corporation.

- (f) To make contracts and quarantnes and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
