We, the undersigned subscriber to these Articles of Incorporation, natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I  
NAME AND EFFECTIVE DATE**

**ARTICLE II  
NATURE OF BUSINESS**


