ARTICLES OF AMENDMENT

- 1. The following provisions of the Articles of Incorporation of Mark Two Engineering, Inc., a Florida corporation, file in Tallahassee on February 22, 1996 and amended on October 15, 1998. Thereafter, the Articles of Incorporation were amended on October 1, 2007 containing a typographical error in that the corporation desires to be authorized to issue 1,000 shares of common stock not 10,000 shares of common stock as stated in the Amendment of the Articles filed on October 1, 2007. Therefore, the Articles of Incorporation are hereby amended in the following particulars.
- Article IV, be and it hereby is amended to read as follows: "This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock which shall be designated as "common shares."
- · Article VIII-Preemptive Rights is hereby revoked.
