ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS SLENDER GYM CENTER, INC.



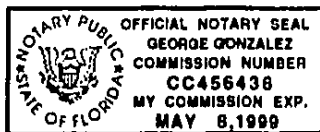


