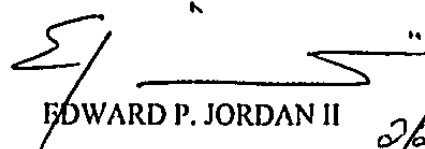

**THE UNDERSIGNED**, acting as sole incorporator of **OLD FASHIONED BLOOMERS, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

### **Initial Board of Directors**

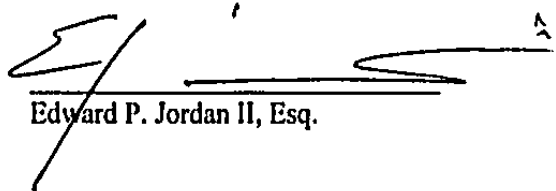
