ARTICLES OF INCORPORATION  
OF

The undersigned Incorporators, for the purpose of forming a Corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Walker's Septic Tank Service, Inc.

PRINCIPAL OFFICE AND ADDRESS

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

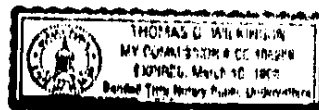
