Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned Florida corporation (hereinafter referred to as the "Corporation") hereby adopted the following Articles of Amendment to its Articles of Incorporation:

**1. Adoption and Text of Amendments**

The sole shareholder of the Corporation unanimously approved a resolution amending Article I of the Articles of Amendment to the Articles of Incorporation by written consent dated the 31<sup>st</sup> of August, 2000, executed in accordance with the provisions of Section 607.0704 of the Florida Statutes, and the number of votes cast for the Articles of Amendment to the Articles of Incorporation was sufficient for approval of said amendment. The following is a true and correct copy of the Resolution amending Article I of the Articles of Amendment of the Articles of Incorporation:

**"RESOLVED**, that Article I of the Articles of Amendment to the Articles of Incorporation of the Corporation is hereby amended in its entirety and shall hereafter read as follows:

**ARTICLE I - NAME OF CORPORATION**


The name of this Corporation shall be SVO International, Inc."

**2. Effective Date of Amendment**
