ARTICLE I  
NAME

The name of the Corporation is: THE GUTTRON CORPORATION, a domestic corporation which is not a member of any affiliated group.

ARTICLE II  
PRINCIPAL OFFICE

ARTICLE III  
PURPOSE

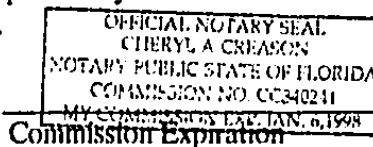
