#### ARTICLE I

#### Name

At each election for a director every shareholder entitled to vote in the election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing the votes on the same principal among any number of candidates.

The Corporation shall indemnify any officer or shareholder, or any former officer or shareholder, to the full extent permitted by law.

## ARTICLE XII

# Amendment

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
