The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

Article I - Name

The name of this corporation is NIX JANITOR SERVICE, INC.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Shares

The aggregate number of shares which the corporation shall have authority to issue shall be 100 of a par value of 10 cents cents per share.

Article V - Registered Office and Registered Agent

The street address of the initial registered office and principal office of this corporation is 1866 W. 45th Street, Jacksonville, Florida 32209, and the name of the initial registered agent of this corporation at that address is Louis Nix, Sr..

Article VI - Initial Board of Directors

The corporation shall have one director initially.

Thereafter, the number of directors may be either increased or decreased from time to time in the manner provided by the Bylaws. The name and address of the initial director of this corporation are:

The corporation shall have the power to indemnify all officers and directors and former officers and directors to the fullest extent permitted by law.


Article IX - Amendment


