- 3. Provisions concerning management and regulations:
  Operations shall be broken down into four departments 1) Editorial,

  Administration. The Editor shall oversee Editorial; the
  Circulation/Distribution Director shall oversee Circulation/Distribution;
  the Associate Publisher shall oversee Advertising/Marketing; the
  Office Manager shall oversee Administration; and the Publisher shall oversee all operations.
- 4. Powers of corporation, board of directors and shareholders: The CEO (chief executive officer) is the majority shareholder. The CEO shall control the operation of Starpoint Inc. The CEO is the final decision-maker in all matters, including Editorial, Advertising/Marketing, Circulation/Distribution and Administration. An Advisory Board will consist of 11 members, one each representing the following fields: sports, travel, film, music, television, retail/business. legal and finance, in addition to the three directors (CEO, publisher and associate publisher). The purpose of the advisory board is to provide the publication with guidance in terms of its editorial content, business and financial dealings and all policies regarding the communities and industries it serves. Meetings shall take place once a year. Transportation and lodging shall be provided by Starpoint Inc.
- 7. Miscellaneous provisions: No employee will accept any cash nor gifts (such as CDs, t-shirts, etc.,...) with a value in excess of \$50. Gifts that can be "consumed" within 48 hours, such as concert tickets or dinner, may be acceptable with the publisher or editor's permission. Complimentary passes, accommodations or airline tickets can be accepted by an employee only if the employee has been assigned to cover the event by the editor.
