ARTICLES OF INCORPORATION OF

CHAR-HUT OF SILVER LAKES, INC.

ARTICLE I CORPORATE NAME

The name of the corporation is CHAR-HUT OF SILVER LAKES, INC.

DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
