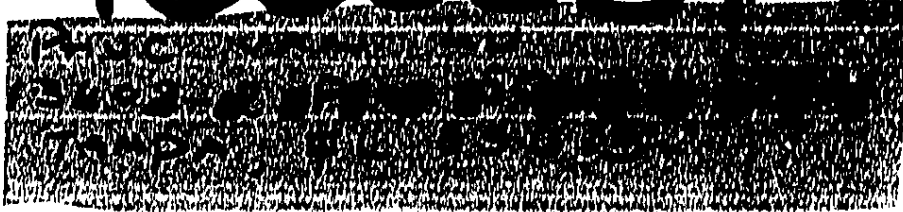

THE UNDERSIGNED acting as imcorporations of a  
corporation under the Florida General Corporation Act, adopt  
the following Articles of Incorporation for such corporation

ARTICLE I. NAME.

The name of the corportation is CHEEVON SERVICES INC.



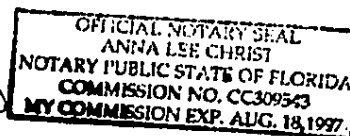
