#### ARTICLE I

#### NAME

The name of the corporation is: Physician Network of Melbourne, Inc.

#### ARTICLE II

#### INITIAL OFFICE

The initial registered office of the Corporation shall be 516 N. Harbor City Blvd., Melbourne, Florida 32935. The initial registered agent of the Corporation shall be John R. Kancilia.

#### ARTICLE III

#### PRINCIPAL PLACE OF BUSINESS

The principal office and place of business of the Company is 1402 Oak Street, Melbourne, Florida 32901.

#### ARTICLE IV

#### **PURPOSE**

The purposes of the Company shall include the following:

- (1) To work with managed care organizations to provide for the cost-effective delivery of health care goods and services through an integrated delivery system of physicians, hospitals and other health care providers in the State of Florida, and to take such lawful actions as may be reasonably necessary or appropriate to accomplish such purpose;
- (2) To provide practice management services to physicians and physician group practices, and to take such lawful actions as

may be reasonably necessary or appropriate to accomplish such purpose; and

(3) To engage in any other lawful activities and businesses as the Directors shall determine.

#### ARTICLE V

#### INCORPORATOR

The Incorporator shall be John R. Kancilia, whose address is 516 N. Harbor City Blvd., Melbourne, Florida 32935.

#### ARTICLE VI

#### STOCK

The Corporation shall have the authority, exercisable by its Board of Directors, to issue 10,000 shares of Class A Common Stock, par value \$0.01 and 10,000 shares of Class B Common Stock, par value \$0.01. Each class of stock shall have the right to elect its own Directors, as defined below. Each share of Class A and Class B Stock shall have:

- (i) equal rights upon dissolution and liquidation of the Corporation;
- (ii) equal right to such distribution or dividends as shall be declared by the Board of Directors; and
  - (iii) equal voting rights within each class.

#### ARTICLE VII

#### DIRECTORS

The Corporation shall have not less than five (5) nor more than fifteen (15) Directors. The Board of Directors shall be divided into two classes: (i) the "Class A Directors", consisting of not less than three (3) nor more than thirteen (13) physicians who shall be nominated and elected by the Class A Shareholders as a group; and (ii) the "Class B Directors", consisting of two (2)


