ARTICLE I - NAME

The name of this Corporation is AET Management, Inc., and the principal business address of the Corporation is 3530 Enterprise Way, Green Cove Springs, Florida 32043.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of the Articles of Incorporation which is February 22, 1996, and shall be filed with the Secretary of State within 5 business days from said date. This Corporation shall have perpetual existence.

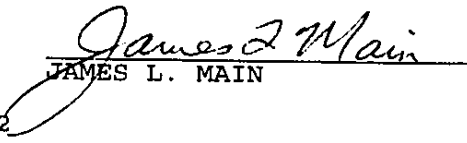
