**Article IV - Capital Stock**

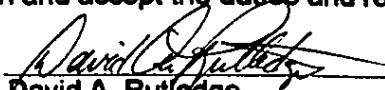
The corporation is authorized to issue one hundred shares (100) of Ten dollars (\$10.00) par value Common Stock, which shall be designated "Common Shares."

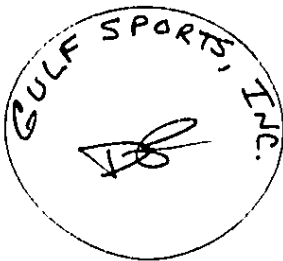
