ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a corporadiation pursuant to Chapter 607, of the laws of the State of Florida, do heroby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation shall be:

RMF, INC.

ARTICLE TWO

This Corporation shall exist in perpetuity commencing on the date of the filing of these Articles of Incorporation by the Secretary of State.

ARTICLE THREE

This corporation is organized for the purpose of engaging in every aspect and phase of the computer hardware and software business including computer repair and installation for both commercial and residential purposes; and furthermore to engage in overse transaction of any and all business permitted under the laws every transaction of any and all business permitted under the laws of the United States and the State of Florida.

ARTICLE FOUR

The aggregate number of shares which this corporation is authorized to issue shall be ONE THOUSAND. Such shares shall be of a single class and shall have a par value of ONE DOLLAR per share, which shall be designated "Common Shar. .

ARTICLE FIVE

The holders of record of the Common Shares shall be entitled to cash dividends when and as declared by the Board of Directors in the resolution authorizing such cash dividends.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.
