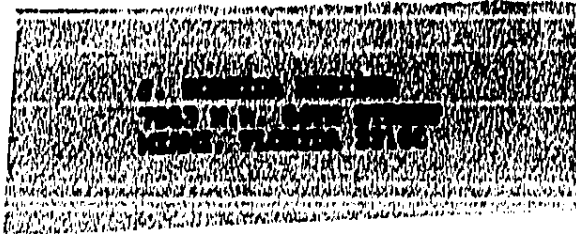

The undersigned subscribers to the Articles Of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida:

ARTICLE I - NAME

The name of the Corporation is:

BONEXPRESS, INC.

ARTICLE II - DURATION

The Corporation shall exist perpetually.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by the Corporation is:
Any activity or business permitted under the laws of The Unite States of America
and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock having a par value of ten dollars (\$10.00)
per share.

ARTICLE V - INITIAL AGENT AND REGISTERED OFFICE

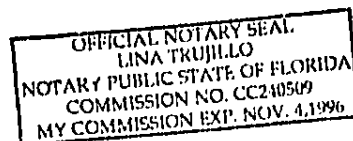

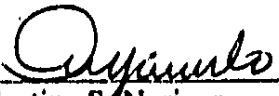

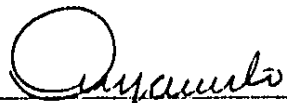
