ARTICLE ONE

The name of the corporation is **PRESSURE CLEANING UNLIMITED, INC.** The principal address of the corporation is: 300 S.W. 77 TERRACE, NORTH LAUDERDALE, FLORIDA 33068.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE
