ARTICLES OF INCORPORATION

OF

COMMUNITY SURGICAL SPECIALISTS, P.A.

The undersigned hereby forms a Professional Service Corporation under the laws of the State of Florida, and under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be COMMUNITY SURGICAL SPECIALISTS, P.A.

ARTICLE II

The principal office and mailing address of the Corporation is 210 Jupiter Lakes Boulevard, Building 3000, Suite 105, Jupiter, FL 33458.

ARTICLE III

The general nature of the business to be transacted by this Corporation shall be to engage in every aspect of the practice of medicine. The Corporation shall not engage in any business other than the practice of medicine. However, the Corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, and may own real and personal property necessary for the rendering of medical services.

ARTICLE IV

The Corporation shall have the authority to issue Five Hundred (500) shares of common stock with a par value of One Dollar (\$1.00) per share.

ARTICLE V

The period of this Corporation's existence is perpetual.

ARTICLE VI

The street address of the initial Registered Office of this Corporation is 210 Jupiter Lakes Boulevard, Building 3000, Suite 105, Jupiter, FL 33458; and the initial Registered Agent of this Corporation at that address is RONALD S. ZELNICK, M.D.

ARTICLE XI

- 1. The only shareholders of this Corporation shall be other professional corporations, professional limited liability companies, or individuals who themselves are duly licensed or otherwise legally authorized to practice medicine under the laws of the State of Florida.
- 2. No shareholder of the Corporation shall enter into a voting trust agreement or other type agreement vesting another person with the authority to exercise the voting power of any or all of that shareholder's stock.

- 3. If any officer, shareholder, agent or employee of this Corporation who has been rendering professional services to the public becomes legally disqualified to render such services within the State of Florida, or accepts employment that, pursuant to existing law, places restrictions or limitations upon his continued rendering of such professional services, he shall sever all employment with, and financial interest in the Corporation.
- 4. No shareholder of the Corporation may sell or transfer his stock in this Corporation except to another professional corporation, professional limited liability company, or individual, each of which must be eligible to be a shareholder of the Corporation.
