# ARTICLES OF INCORPORATION ARTICLE ONE

ATABEY CORP.

The name of this corporation is: ATABEY CORP.

The principal office and mailing address of this corporation is: 1840 WEBT 49TH STREET-STE. #605, HIALEAH, FL. 33012

## ARTICLE TWO

## NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

## ARTICLE THREE

#### DURATION

This corporation shall have perpetual existence unless sconer dissol--ved in accordance with the laws of the State of Florida. The date on -which corporate existence shall begin is: UPON APPROVAL BY SECRETARY --OF STATE.

### ARTICLE FOUR

#### CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

- A- Designation. The stock of this corporation shall be known as Common Stock.

- F- Voting Rights. Each share of Common Stock shall entitle the -record holder thereof to one vote upon each proposal presented at meetings of the stockholders of the corporation.

- G- Dividends. Record holders of Common Stock are entitled to re-neive their pro-rate share of any dividends that may be declar-red by the Board of Directors out of assets legally available for such purpose.
- H- Liquidation Rights. Holders of Common Block are entitled, in --the event of the liquidation or dissolution of this corporation to receive their pro-rate share of any assets of this corpora--tion remaining after payment of all corporate debts and obliga-tions.

#### ARTICLE EIGHT

### PREEMPTIVE RIGHTS

### ARTICLE NINE

51% of the shares entitled to vote, represented in person by proxy, -- shall constitute a quorum at a meeting of shareholders.

If a quorum is present, the affirmative vote of 51% of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

## APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER
