ARTICLE I - NAME

The name of the corporation is SOUTH FLORIDA FISHERIES & LAKE SERVICES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

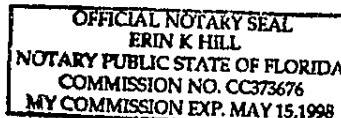


