ARTICLES OF INCORPORATION  
OF

I, THE UNDERSIGNED INCORPORATOR(S), FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, HEREBY ADOPT(S) THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I - NAME

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE II - DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY. COMMENCING ON THE DATE OF Filing AND ACKNOWLEDGMENT OF THESE ARTICLES.
