The undersigned subscriber to these Articles of Incorporation, EDWARD D. HOLLOWAY, being a natural person competent to contract, desiring that he be incorporated for such purposes, does hereby make, execute and adopt the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be ALL-AMERICAN PETROLEUM & SERVICES, INC.

ARTICLE II

The general powers of this corporation shall be all corporate powers.

ARTICLE III

The maximum number of shares that this corporation is authorized to have outstanding at any time is TEN THOUSAND (10,000) shares of common stock, of the par value of ONE AND NO/100 dollars (\$1.00) per share.

The whole or any part of the authorized capital shares may be issued for such consideration having a value of not less than par value of the shares issued therefor, as is determined from time to time by the Board of Directors.

ARTICLE IV

The amount of capital with which this corporation shall begin business is TEN THOUSAND AND NO/100 (\$10,000.00).

ARTICLE V

This corporation shall have and continuously maintain in this state:

A. A principal office and the initial registered office is hereby designated as 343 Dennard Avenue, Jacksonville, Florida, 32254.

B. A registered agent and the initial registered agent is EDWARD D. HOLLOWAY, 343 Dennard Avenue, Jacksonville, Florida 32254.

The Board of Directors may, from time to time, change its registered office or its registered agent, pursuant to Section 607.037, Florida Statutes.

ARTICLE VI

This corporation shall have perpetual existence and the commencement of the corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Department of State, State of Florida.

ARTICLE VII

The corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by the By-Laws adopted by the stockholders.

ARTICLE VIII

The name and address of the member of the initial Board of Directors of this corporation, who, subject to the provisions thereof, the By-Laws of this corporation and the laws of the State of Florida, will hold office for the first year of the

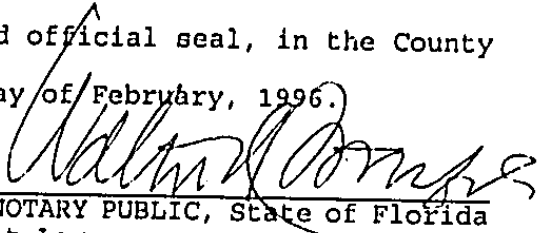
