# ARTICLE 1

The name of this Corporation is: SURFSIDE FINANCIAL SYSTEMS CORP. whose address is 821 East Broward Boulevard, Ft. Lauderdale, FL 33301.

#### ARTICLE 2

The Corporation has perpetual existence unless otherwise specified in these articles.

## ARTICLE 3
