We, the undersigned, with other persons being desirous of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, do agree to the following:

ARTICLE I. NAME

The name of the corporation shall be:

FILMIX OUTDOOR SIGNS, INC.

The address of the principal office of this corporation shall be 603 Stadium Road, Auburndale, Florida 33823, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
