# ARTICLES OF INCORPORATION

# ARTICLE I - NAME

The name of the corporation is Flamingo Software Company, Inc.

### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
