**OFFICERS AND DIRECTORS**

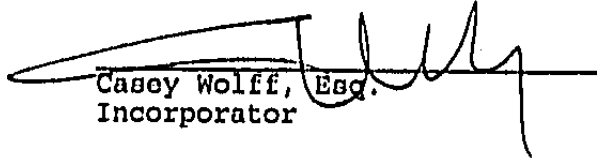
