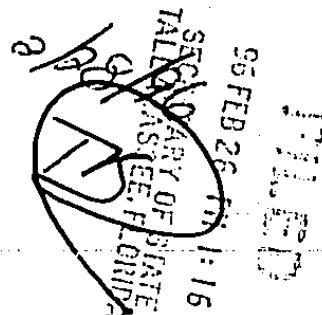

**ARTICLES OF INCORPORATION  
of  
ISTHMUS SERVICE GROUP, INC.**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be ISTMUS SERVICE GROUP, INC.

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**
