SECRETARY OF STATE

I, the undersigned, hereby organize for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of Statutes of the said state of Florida, providing for the formation, rights, privileges, immunities and liabilities of Corporations for profit.
