ARTICLE ONE

The name of the Corporation is PAGECOM CELLULAR, INC.

ARTICLE TWO

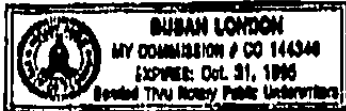
