

I, the undersigned, pursuant to the laws of the State of Florida, do hereby subscribe, acknowledge, and file in the Office of the Secretary of State of the State of Florida, the following Articles of Incorporation, to wit:

#### ARTICLE\_I

The corporate name shall be NATIONAL SUPPORT SERVICES, INC.

#### ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the State of Florida and of the United States.

#### ARTICLE III

- The number of shares of authorized capital stock of this corporation shall be Seven Thousand Five Hundred (7,500) shares of common stock with a nominal par value of One Dollar (\$1.00) cach.
- 2. The capital stock may be paid for in property, labor, services or cash, at a just valuation to be fixed by the stockholders. All of such stock shall be fully paid and non-assessable.

#### ARTICLE\_IV

The amount of capital with which this corporation will begin business shall not be less than Five Hundred (\$500.00) Dollars.

#### ARTICLE V

The term for this corporation shall be perpetual.

#### ARTICLE VI

The principal office of the corporation shall be at 11844 West Sample Road, Coral Springs, Florida 33065. This corporation may have such other places of business in the State of Florida as the nature and progress of the business of the corporation shall from time to time move the principal office to any other address in Florida.
