ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: **MAR'S PRESSURE WASHING & PAINTING, INC.**, a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 7602 Central Park Circle, Tampa, FL 33637.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of pressure washing and painting; and
2. 
