Charter of Articles of Incorporation:

ARTICLE I

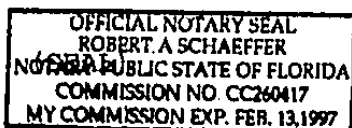




