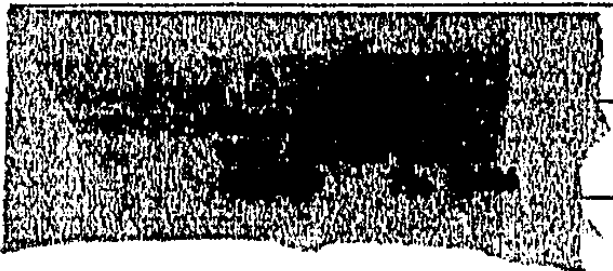

ARTICLES OF INCORPORATION

ARTICLE ONE

NAME

The name of this incorporation is:

J.C. & SON MASONRY INC.

ARTICLE TWO

NATURE OF BUSINESS

This incorporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida

ARTICLE THREE

DURATION

This incorporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida.- The date on which incorporate existence shall begin in: February 8, 1996.

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

A. Designation. The stock of this corporation shall be known as Common Stock.

B. Authorized: The maximum number of shares of Common Stock that this incorporation may issue is: 60.

C. Par Value: Each share of Common Stock shall have the par value of \$ 1.00 .

G. Dividends: Record holders of Common Stock are entitled in the event of pro-rata share of any dividends that may be declared by the Board of Directors out of assets legally available for such purpose.

H. Liquidation rights: Holders of Common Stock are entitled, in the event of liquidation or dissolution of this corporation, to receive their pro-rat share of any assets of this incorpora-

tion remaining after payment of all corporate debts and obligations.

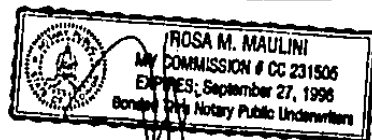
